## **Cursillo Health Agreement**

In order to protect Cursillo candidates, team, volunteers, guests, and associated facility staff, Episcopal Cursillo of Oregon and SW Washington will implement appropriate policies and practices to safeguard the health of all these participants. This policy is in addition to any rules or regulations required by facilities where Cursillo activities are held, or local, state, or federal guidelines and regulations.

For in-person gatherings, participants agree to forgo attending events while considered to be infectious, as per current federal, state, and local guidelines. Symptoms may include the following:

- 1. Respiratory illness colds, pneumonia, flu, coronavirus, or other similar illnesses that are contagious
- 2. Fever greater than 100.4 degrees F from any cause, or fever more than two (2) degrees above your norm, feeling feverish, sweating, chills
- 3. New onset cough
- 4. New onset shortness of breath or difficulty breathing
- 5. New onset muscle aches, body aches
- 6. New onset headache
- 7. New onset congested or runny nose, not related to allergies
- 8. New onset nausea or vomiting
- 9. New onset sore throat
- 10. New onset loss of taste or smell
- 11. New onset nausea or vomiting
- 12. Diarrhea for more than a day
- 13. Unusual fatigue
- 14. Any other symptom that may be identified by the CDC or State Health Departments.
- I acknowledge that Episcopal Cursillo Ministry of Oregon and SW Washington, the Episcopal Diocese of Oregon, the facility, or any individual cannot guarantee that I will not become infected with COVID-19 or other infectious disease and I understand the risk of being exposed may result from the actions, omissions, or negligence of myself or others.
- I voluntarily choose to participate in Cursillo activities and acknowledge the risk that I am taking for myself and those in my household.
- I acknowledge that I must comply with practices and procedures (e.g., temperature checks, masking) that are in place at the time of Cursillo-related activity to reduce the spread while participating in any Cursillo activity or event.

WAIVER OF LIABILITY: I realize and waive my right to bring any action against Oregon and SW Washington Episcopal Cursillo, the Episcopal Diocese of Oregon, facilities or any representative in connection with exposure, infection, and/or spread of COVID-19 or other infectious diseases related to participation in Cursillo activities.

ASSUMPTION OF RISK: I have read and understood the above warning concerning COVID-19 and other infectious diseases. I voluntarily choose to accept the risk of contracting COVID-19 or other infectious diseases to participate in Cursillo activities. As a Cursillo participant, I will adhere to the requirements noted above, and any additional practices provided by federal, state, local, diocesan, or facility authorities.
